Officers investigated a vehicle crash occurring at the intersection of Highway 59 and Missouri D Highway (Lyon Drive.) Two vehicles had been eastbound on Lyon Drive approaching Highway 59. Both vehicles entered the right turn lane, preparing to travel northbound on Highway 59. The vehicles entered the merge lane and the front vehicle (vehicle two in this report) slowed or stopped in the road and was struck from behind by the following vehicle (vehicle one.)

I spoke with the driver of vehicle one, identified as Adriana Vance. Ms. Vance reported she followed vehicle two into the right turn merge lane. This intersection has no traffic control and the lane ends after a few hundred yard forcing traffic to merge left into the northbound lanes. Ms. Vance reported she looked over her shoulder checking traffic on Highway 59 and when she looked back the vehicle ahead of her had stopped in the road; she was not able to stop her vehicle before colliding with vehicle two. Ms. Vance reported no injuries but stated her passenger needed medical attention. The passenger was checked by ambulance personnel and Ms. Hanger declined transport for herself or the passenger. There was no visible injury.

I spoke with the driver of vehicle two, identified as Teresa Hanger. Ms. Hanger gave the same description stating she was turning north onto Highway 59 when she was struck from behind by vehicle one. Ms. Hanger stated she was confused by the merge lane and the approaching traffic on Highway 59 and she may have stopped in the road but she couldn't remember if she came to a full stop or not. She reported no injuries and her vehicle didn't require tow.
