

On 06/25/2014 at approximately 1334 hours, I was dispatched to the intersection of South Wood Street and West McKinney Street in reference to a report of a traffic accident.

Upon arrival, I spoke with David LaPlante. Mr. LaPlante stated he was traveling south bound on South Wood Street in his 2000 International Tractor Trailer unit. Mr. LaPlante stated he attempted to make a right hand turn (west) on to McKinney Street. As he attempted the turn, he realized he was not going to be able to make the turn without backing up. Mr. LaPlante stated as he was backing up, a female subject stopped him and told him he had hit her car.

I spoke with Michelle Pippin. Ms. Pippin stated she was walking to her car that was parked facing north on the east side of South Wood Street just north of McKinney Street. Ms. Pippin advised she watched as the Semi attempted to make the right hand turn. Halfway through the turn, the Semi stopped and started to back up. While the Semi was backing up, the trailer hit the left rear fender of her car.

When I arrived on scene, Ms. Pippin's vehicle was still parked on the east side of South Wood Street. However, it was not near the intersection of McKinney Street. I asked both driver's about this. Ms. Pippin advised she moved her vehicle after the crash happened. Mr. LaPlante confirmed this and also stated he moved his Semi after the crash in order to let traffic by. Due to both vehicles being moved prior to my arrival, no measurements were taken.
