



On 08-17-2014 at approximately 17:44 hours, I responded to the area of Washington Avenue and North College Street in reference to a traffic crash.

Upon arrival I observed a Gold Chevrolet HHR with minor damage to the front. I observed a blue Dodge Ram 2500 with no visible damage to the vehicle.

I first made contact with the driver of the HHR, identified as Cindy Bryan. Ms. Bryan stated she was behind the Dodge at the stop sign at Washington Avenue and North College Street. Ms. Bryan stated she observed the Dodge start to back up and she didn't have time to react. Ms. Bryan stated the Dodge back into the front of her HHR.

After speaking to Ms. Bryan, I made contact with the driver of the Dodge identified as Paul Kyger. Ms. Kyger stated he was at the stop sign of Washington Avenue and North College Street when he observed a truck and trailer attempting to turn onto Washington Avenue. Mr. Kyger stated he was backing up so the truck and trailer could make the turn. Mr. Kyger stated the sun was in his eyes and he didn't see the HHR behind him.

Vehicle were moved prior to my arrival. I was unable to identify an intial point of impact and no measurements were taken at this time.

I have no further to add at this time.
