




On 08/22/2014 at approximately 1008 hours I responded to the area of North Neosho Boulevard and West South Street in reference to a traffic accident.

I arrived at the intersection of N. Neosho Blvd and W. South St. in reference to a (4) vehicle traffic accident. All (4) vehicles had been removed from the roadway and were parked in a vacant lot on the North side of Wildcat Corner.

I spoke to Matthew Bickford, Driver 1, who stated he was travelling North on N. Neosho Blvd. Mr. Bickford stated he crossed through the intersection at W. South St. and saw Vehicle 2 stopped in traffic, North bound, in the left lane. Mr. Bickford stated he applied the brakes but was unable to stop in time. Vehicle 1 slid and struck the rear of Vehicle 2, causing Vehicle 2 to make slight impact to the rear of Vehicle 3. At that time, Mr. Bickford stated his Vehicle 1 rolled backwards due to the impact and made contact with the front of Vehicle 4, also travelling North bound. Mr. Bickford did not request medical attention and Vehicle 1 was towed by Ron's Towing due to damage.

I spoke to Sandra Simon, Driver 2, who stated that she was travelling North on N. Neosho Blvd and stopped in traffic behind Vehicle 3. At that time, she was struck in the rear by Vehicle 1, causing her Vehicle 2 to strike Vehicle 3 in the rear. Ms. Simon did not request medical attention and her vehicle was not disabled.

I spoke to Ashley Raby, Driver 3, who stated that she was stopped in North bound traffic in the left lane of N. Neosho Blvd. Ms. Raby advised that she was struck in the rear by Vehicle 2. Ms. Raby did not request medical attention and her vehicle was not disabled.

I spoke to Troy Tolles, Driver 4, who stated he was travelling North on N. Neosho Blvd. Mr. Tolles stated that as crossed the intersection with W. South St., he observed Vehicle 1 strike Vehicle 2 in the rear. Mr. Tolles slowed to a stop due to the accident and Vehicle 2 rolled backwards into the front of his Vehicle 4. Mr. Tolles did not request medical attention and his vehicle was not disabled.
