



On Monday, August 25th, 2014 at 16:04 hours, I responded to the intersection of Business Interstate 49 and Baxter Street, to investigate a reported non-injury traffic crash.

The traffic crash occurred as vehicle 1, a white 2002 Ford Taurus displaying Kansas registration of 283DJY, was being actively pursued by law enforcement officers. During the pursuit vehicle 1 crossed the lanes of travel and struck vehicle 2, a 2013 silver Dodge Caravan displaying Oklahoma registration of CA5550.

I spoke with Ms. Tamara Glover, the driver of vehicle 2, who explained she was traveling westbound on Business Interstate 49 near Baxter Street when she observed vehicle traveling in her direction. She explained she attempted to merge into the outside lane of travel in an attempted to avoid the colliding with vehicle 1. She said she was unable to merge due to other vehicle in the lane and was struck on the rear passenger side of her vehicle.

Ms. Glover advised she was un-injured in the traffic crash. Ms. Glover's two boys Guner and David were also in the vehicle at the time of the crash and Ms. Glover explained they were also un-injured.

Mr. Keith McDonald the driver of vehicle 1, was treated on scene by Newton County Ambulance District medical personnel for a medical issued he was having.
