




I responded to a past tense vehicle crash on Doniphan Drive north of Williams Avenue. I observed a single vehicle involved. I could see apparent tire indentions in the grass coming off the apex of a curve on the northbound side of Doniphan Drive. The vehicle had exited off the right side of the roadway and onto the grass. There was a small grade to the grass here and the vehicles back end spun around in a U-turn type fashion. The left side of this vehicle struck a tree line about five feet off the roadway disabling it.

I spoke with the vehicle driver, Chance Burr. Mr. Burr was transported by family to the hospital for treatment but there was no visible injury. Mr. Burr reported he was traveling north when his vehicle began to wobble. He reported he thought the tire had blown but he was unsure exactly. He lost control and left the roadway spinning into the tree line.

The passenger had left and was not available for interview. The vehicle was disabled from the crash but was not obstructing the roadway or traffic. It remained at the scene until the owner could return for it. This vehicle was a new purchase and was not yet registered in the current owners name.
