



On 10-09-2014, at approximately 1450 hours, Officer Berry and I responded to the area of Benham Avenue and Wall Street for a leaving the scene of an accident. Officer Berry arrived at 409 Benham Avenue and was advised a blue tractor pulling a trailer tore down a cable line and left northbound on Wall Street.

I located a blue tractor pulling a trailer that was traveling east on Baxter Street at Main Avenue. I stopped the truck and spoke with the driver, Thomas Risberg. I asked Mr. Risberg if he had been driving around the northend of town and he said he had. Mr. Risberg said he was lost and had been following his Global Positioning System.

I asked Mr. Risberg if he hit a cable line and he said he didn't know he hit a cable, but he did stop and pull a cable off of his rear bumper that he thought he drove over on the road.

On 10-09-2014 at approximately 14:50 hours, Officer Schlessman and I responded to the area of Benham Avenue and Wall Street in reference to a traffic crash.

I spoke with Tommy Lauderdale at 409 Benham Avenue. Mr. Lauderdale stated he observed an 18 wheeler with a blue cab turn west bound onto Benham Avenue from Broadway Avenue. Mr. Lauderdale stated the 18 wheeler was too tall and collided with a utility line over the roadway. Mr. Lauderdale stated the 18 wheeler did not stop. Mr. Lauderdale stated the 18 wheeler turned northbound onto Wall Street with the utility line still attached to it.
