

On 11/27/2014 at approximately 18:42 hours I responded to the intersection of Walnut Street and Neosho Boulevard for a two vehicle traffic accident.

When I arrived on scene I observed two vehicles were involved. Vehicle one was a blue in color General Motors Company pickup Bearing Missouri 6DS-597. Vehicle two was a grey in color Chevrolet Aveo bearing Missouri PL2-T5J. Vehicle one was driven by Alisha Bracht. Vehicle two was driven by April Tygart.

I spoke with Mrs. Bracht. Mrs. Bracht stated that vehicle two was driving North bound on the Neosho Boulevard in the same lane in front of her. Mrs. Bracht stated that Vehicle one abruptly applied her brakes and stopped for no reason within the lane of travel.

Mrs. Bracht stated she had absolutely no time to stop. Mrs. Bracht had two Juvenile passengers in the vehicle with her. The names of the passengers are included in the person section of this report. She stated none of them were injured and did not need medical attention.

I spoke to Mrs. Tygart. She stated she pulled out of McDonalds parking lot into the inside lane heading northbound on Neosho Boulevard. She stated she legally changed lanes into the outside lane and noticed the speed limit was dropping to thirty miles per hour. She stated she slowed down to that speed limit when she was hit in the rear by vehicle one.

She had three passengers in the vehicle with her and each one is listed in the person's section of this report. I asked each one if they were injured and needing medical attention, they informed me they were not. She was checked out by Newton County Ambulance and refused treatment.

I spoke with a witness who identified himself as David Vanryn of Neosho. Mr. Vanryn stated that he was behind vehicle one when the accident occurred. He stated vehicle two was traveling northbound on Neosho Boulevard and it appeared to him that vehicle one attempted to speed up which resulted in driving into the back of vehicle two.

Vehicle two was towed by Dickson towing due to disabling damage. Vehicle one was driven from the scene.

I have nothing to report at this time.
