




On 01-10-2015 around 18:24 hours, I was dispatched to the intersection of Park Street and Freeman Road for a non injury accident report.

Upon my arrival to the scene, I observed a white pickup truck facing South on Freeman Road in the ditch. I noticed an elderly female sitting in the driver seat of the pickup and identified her by Arkansas driver's license as Virginia Huber. I asked Ms. Huber if she was injured and needed any medical attention. She told me that she was ok and would not need medical attention.

I asked Ms. Huber what happened and she told me that she had just dropped off her grandson at his home on Park Street. She said she has a lot of trouble seeing at night and when she went to turn onto Freeman Road she did not see the ditch and turned into it.

I asked Ms. Huber who she would like to have come out and get her pickup out of the ditch. She asked for me to contact Poore's Towing to pull it out. I had Central Dispatch contact Poore's Towing and they responded, pulling the pickup out of the ditch. The pickup was driven away from the scene by another licensed driver.

I told Ms. Huber that if she has trouble seeing in the dark that she should not be driving when the sun goes down. I filled out a Missouri Department of Revenue driver condition report on Ms. Huber, which is attached to this report.
