



On 01/20/2015 at approximately 0730 hours, I responded to the area of West Harmony and North Business 49 in reference to a (2) vehicle traffic accident.

I responded to W. Harmony St. where (2) vehicles were involved in a traffic accident in east turn lane. Due to traffic volume, both vehicles were moved into the parking lot of Griffith Motors.

I made contact with Driver 1, Jeffrey Parman and Driver 2, Ryan Anderson.

Mr. Parman advised he was travelling behind Vehicle 2 as they both turned east bound onto W. Harmony St. Mr. Parman stated that both vehicles merged into the turn lane. As Vehicle 2 slowed to a stop to make a left turn, Mr. Parman was not able to stop in time and his Vehicle 1 slid and struck Vehicle 2 in the rear. Mr. Parman stated he was not injured and his Vehicle 1 did not sustain front end damage due to the impact.

I made contact with Driver 2, Ryan Anderson. Mr. Anderson stated he was travelling south on N. Bus 49 and turned east onto W. Harmony St. Mr. Anderson advised he merged into the turn lane with the intention of making a left turn into Griffith Motors. Once in the turn lane, Mr. Anderson slowed to a stop to make the turn and was struck in the rear by Vehicle 1. Mr. Anderson's Vehicle 2 sustained rear end damage and also rear window damage due to the impact. Mr. Anderson stated he was not injured and his vehicle was not disabled.

When I initially arrived on scene, both vehicles remained in the turn lane with Vehicle 1 stopped a few feet behind Vehicle 2. Due to high traffic volume, both vehicles were moved into the parking lot of Griffith Motors, therefore, no accurate measurements were obtained.
