

On 02-06-2015 at approximately 0640 hours I responded to the area of Business 49 and Eric Road, in reference to a traffic crash. A report was taken.

I was advised by Central Dispatch that the person who called the accident in, witnessed a tan in color Chevy Silverado traveling south on Business 49 drive off the roadway and across Eric Roadway into the ditch. The caller also told Central Dispatch that the driver of the truck appeared to be having some type of medical problem.

I arrived on scene and observed the front of the truck was partially in the ditch and most of the back of the truck was blocking Eric Road. I made contact with the driver of the truck identified as Leonard Bates and asked if he was ok, he said he was fine just had a medical issue. I asked if he needed to go to the hospital, he said no he was fine. I told him that Emergency Medical Services was on their way so they could at least evaluate him. While waiting on the ambulance to arrive I asked Mr. Bates what happened. He said he was traveling south on Business 49 when he started feeling sick. He explained he was going to pull over and wait for a little bit hoping he would start to feel better. Mr. Bates stated he began to pull over and drove off the roadway into the ditch and struck a culvert on the north side of Eric Road, then continued across Eric Road into the ditch on the south side.

The ambulance personnel arrived on scene and evaluated Mr. Bates, it was determined Mr. Bates was suffering from a medical issue during the time of the accident. He refused to go the hospital and was picked up at the scene by his son. Mr. Bates truck was towed by Ron's Towing due to disabling damage. There was no other damage was done except to Mr. Bates truck.
