

On 2/10/2015 at around 1541 hours officers were dispatched to the area of Waldo Hatler memorial Drive and Business 49 Highway for a traffic crash.

I arrived on scene and observed two vehicles pulled off the roadway onto the shoulder. Nether vehicle had significant damage.

I made contact with Driver 2 Lorena Cuellar Hernandez (D2). D2 was operating vehicle 2 (V2), a 2002 gray Ford Explorer (V2) displaying Missouri registration WC4C5R. D2 said she was stopped at a red light east bound on Waldo Hatler Memorial Drive. D2 explained she was stopped when a vehicle hit her from behind. D2 then pulled off the road.

D2 had her 2 children in the vehicle and expressed concern they might be injured. I asked if D2 if she wanted me to call an ambulance and D2 declined. I observed no injuries to the children and they acted normal.

I made contact with Driver 1 Natalie Renfro (D1). D1 was in operating vehicle 1, a 2010 gray Chevrolet Traverse displaying Missouri registration YH4C2Z. D1 said she was stopped behind V2 when the light turned green. D1 said V2 began to drive forward then stopped suddenly. D1 explained she was driving forward then could not stop in time and hit V2 in the rear.

D1 had her 4 children in the vehicle and said no one was injured and declined ambulance.

Both vehicles were off the roadway so no measurements were taken. Photos of the damage were taken and included in this report.
