

On Thursday, February 19, 2015 at approximately 2105 hours, I responded to 1014 Hearrell Avenue in reference to a traffic accident involving a motor vehicle in transport and a parked vehicle. I arrived on scene to find vehicle 2 parked on the west side of the road facing north pulled approximately half way off the roadway. There was quite a bit of plastic and other debris in the roadway and next to vehicle 2. I made contact with the owner of vehicle 2, Heather McKinney.

Mrs. McKinney said she was sitting in the house watching TV when she heard a loud noise outside. She said she did not recognize the noise and went back to watching TV. Approximately 5 minutes later, a female subject, later identified as Breanna Melugin, knocked on her door and told her she accidentally hit her vehicle. Mrs. McKinney said Mrs. Melugin stated she was driving south on Hearrell Avenue and a medium sized brown dog was in the street. Mrs. Melugin said she swerved to avoid hitting the dog and began to slide on the ice on the road and struck vehicle 2 in the front right corner of the vehicle. Mrs. McKinney said she had seen a dog matching that description in the street earlier that day. Mrs. McKinney said Mrs. Melugin had gone home prior to my arrival.

I made contact with Mrs. Melugin at her house at 615 Joplin Street. She informed me she was driving south on Hearrell Avenue on her way home. She said once she passed Joplin Street on Hearrell Avenue she noticed a medium sized brown dog that appeared to be walking with a limp in the middle of the street. She said she swerved to avoid hitting the dog, and slid on the ice, striking vehicle 2 in the front right corner.

Both individuals had already traded insurance information before I arrived. Both cars were at the owner's home and did not need to be towed. Mrs. Melugin said she was not injured and declined the need for medical attention. I searched the area and was not able to find the dog that was described by both parties.

I have nothing further at this time.
