

On 02/27/2015 at approximately 1224 hours, I responded to the area of Lyon Drive and Howard Bush Drive in reference to a traffic accident.

I responded to the intersection of Lyon Drive and Howard Bush Drive in reference to a (2) vehicle traffic accident.

I made contact with Driver 1, Franklin Rickert. Mr. Rickert stated he was travelling North bound and attempting to cross the West bound lanes of Lyon Drive and continue North on Howard Bush Drive. Mr. Rickert stated as he entered the West bound lanes of Lyon Drive he did not see Vehicle 2 and made contact with the driver's side, rear passenger door. Mr. Rickert's Vehicle 1 sustained front end damage and he stated he was not injured. Mr. Rickert stated that he made arrangements for a tow truck and the vehicle was moved into The Essentials parking lot.

I made contact with Driver 2, Isaac Gayer. Mr. Gayer stated he was travelling in the left lane, West bound on Lyon Drive. As he entered the intersection with Howard Bush Drive, Mr. Gayer stated he was struck in the driver's side passenger door by Vehicle 1. Mr. Gayer stated he was not injured and made arrangements with a family member to have his vehicle moved from the scene.

Both vehicles had been moved from the scene prior to my arrival due to road blockage, therefore, accurate measurements were not obtained.
