



On Friday, February 27, 2015 at approximately 1950 hours, I responded to the intersection of Howard Bush Drive and Highway 60 in reference to a traffic crash. I arrived on scene to find two vehicles sitting in the turn lane to turn east onto Highway 60 from north bound Howard Bush Drive. Both vehicles were partially blocking the turn lane. Both drivers said they had already moved both cars in an attempt to get out of the way of traffic prior to my arrival. I had both cars pull onto Highway 60 east bound onto the shoulder so they would not be blocking traffic.

I made contact with the driver of vehicle 1, identified as Eric Workman. Mr. Workman said he was travelling north on Howard Bush Drive when he began to merge into turn lane to turn east bound on Highway 60. Mr. Workman said he began applying his brakes approximately 2 car lengths behind vehicle 2 and immediately began sliding. He said he continued to slide and attempted to turn his vehicle to the right, but struck vehicle 2 in the rear passenger side before coming to a stop. Mr. Workman said after he made contact with the driver of vehicle 2, he attempted to move his truck so he would not be blocking traffic.

I made contact with the driver of vehicle 2, identified as Carol Baker. Ms. Baker said she was sitting at the yield sign in the turn lane of Howard Bush waiting to turn east on Highway 60. She said she noticed vehicle 1 start to slide behind her so she attempted to pull forward to avoid being hit, but was struck in the rear passenger side of the rear bumper. She said after making contact with the driver of vehicle 1, she moved her vehicle out of the way.

I did not take measurement at the scene due to the vehicles being moved prior to my arrival. It is to be noted the surface of the road in this location was covered in ice and snow and was extremely slippery. Vehicle 2 sustained minor damage to the rear bumper and was able to drive away from the scene. Vehicle 1 did not sustain any damage at all. Neither driver had any apparent injuries and both refused the need for medical attention.

I have nothing further at this time.
