

On 4/6/2015 at around 1644 hours officers were dispatched to the area of the South Neosho Boulevard and Harmony Street in reference to a traffic crash.

I arrived on scene at the South Neosho Boulevard and Harmony Street; both vehicles had pulled off of the roadway. Both drivers had no visible injuries and refused medical treatment on scene.

I spoke with driver 2 (D2) Susan Hahne who was operating vehicle 2 (V2) a white 2013 Ford Edge displaying Missouri registration ML4K6P. D2 said she was driving on South on the South Neosho Boulevard and pulled into the right turn lane at Harmony Street and stopped for traffic. D2 stated while she was waiting for traffic to clear when she was hit in the rear by vehicle 1.

I spoke with driver 1 (D1) Misty Mendoza who was operating vehicle 1 (V1) a blue 1998 Plymouth Neon displaying Missouri registration PL2R3T. D1 stated she was driving on South on the South Neosho Boulevard and pulled into the right turn lane at Harmony Street. D1 said she thought V2 was still moving and she rolled into the rear of V2.

No witnesses were on scene. No pictures were taken due to very little visible damage.
