

On May 6th at approximately 15:03 I responded to the intersection of S High Street and Hazelwood Drive in reference to a leaving the scene of an accident. I was advised the vehicle that left the scene was described as an older red pickup truck.

Upon my arrival, I observed a vehicle sitting on the side of the road fitting the description of the vehicle involved in the accident, it was parked facing east on the north side of the road on Hazelwood Drive.

I made contact with the driver, Mr. Ryan Peters. I asked Mr. Peters if he had been involved in an accident. He said he had not been in an accident and just noticed he had a flat tire and was getting ready to change it.

I asked him again if he was sure he had not been in an accident? He said he had been in accident.

I asked him to explain what had happened at the intersection of S High Street and Hazelwood Drive. He said he was traveling south on High Street and turned onto Hazelwood Drive and over corrected. He then said he went through the fence and he got scared, so he drove out the other side of the fence to leave. I asked him why he was parked down the street. He said he stopped because he had a flat tire and was going to call his parents and tell them what had happened.

I photographed the damage on Mr. Peters truck. The truck front grill was broken, both of the front turn signal lense were broken, there was a scratch in the paint on the right hand front fender traveling down past the front door. The vehicle passenger door mirror and the part of the F150 emblem were missing from the passenger side of the truck.

I asked for Mr. Peters' driver's license and proof of insurance, which he was able to provide the information.

I went to the address of 1009 S High St to make contact with the property owner, Mr. Terry Thomas. I provided Mr. Thomas with Mr. Peters' insurance information.

Mr. Peters advised he was not injured.
