





On 05-16-2015 at 0900 Hours, I responded to the 400 Block of White Avenue to take a traffic accident report.

Upon arrival at 401 White Avenue, I met Jane Vermillion. Ms. Vermillion stated her mailbox was missing from her yard. Ms. Vermillion stated she noticed her neighbors (405 White Ave) mailbox was located in the opposite ditch from her house.

I walked across the road and noticed tire marks on the opposite side of the street. I also noticed the neighbor's mailbox along with a piece of plastic grille from the front of a vehicle. I attempted to let the neighbors know about their mailbox but was unable to speak with them.

It appeared that vehicle one was traveling northbound when it ran off the right side of the road, striking Ms. Vermillion's and her neighbors mailbox then drove back onto the road and continued northbound.

I later found Ms. Vermillion's Mailbox in the parking lot of 201 White Avenue. I received information that Pedro Rodriguez was the driver of the 2001 Pontiac Sunfire bearing Kansas registration (762GLG) which crashed into Ms. Vermillion's Mailbox. I noticed the front bumper was damaged. I matched the piece of grille up with the vehicle and it was a match.
