



Upon my arrival to the scene, I observed a blue truck, vehicle 1, with Missouri registration # 4AM935 and a green sport utility, vehicle 2, with Missouri registration # YB8H5W Mo. Both vehicles were sitting on the right shoulder on the Highway, facing west bound. I observed two females and a male standing on the shoulder of the roadway near the vehicles. The drivers advised that their vehicles were operable, so they drove out of the road and onto the shoulder.

I identified the driver of vehicle 1 by his Missouri driver license as Buddy Bice. Mr. Bice said he was traveling west on Highway 60 when his little dog jumped in his lap. He said he took his eyes off the road for a second and rear ended vehicle 2.

I spoke with the driver of vehicle 2, identified by her Missouri driver license as Rachelle McKnight. Mrs. McKnight said she was sitting at the stop light with three vehicles in front of her at the light. She said "out of the blue", she was struck in the rear end by vehicle 1. She said that after the first impact the truck then rolled forward again, striking her vehicle again.

I asked both drivers if they were in need of any medical attention, Mr. Bice said he was not hurt and did not need medical attention. Mrs. McKnight said she and her passenger Susan Ewing were not injured. Mrs. McKnight said her back felt stiff and she had a doctor's appointment already scheduled prior.

Vehicle one had minor damage to the front headlight area. Vehicle two had damage to the rear bumper area. Due to only minor damages to the vehicles, the drivers were able to leave the scene with their vehicles.
