

I responded to a motor vehicle accident located on US Hwy 60 at the I-49 exit ramp. Upon my arrival both vehicles had already moved from the roadway.

I made contact with vehicle one's four occupants to check for injuries. The second right passenger was complaining of neck and back pains however he later declined medical treatment at the scene. All other occupants of vehicle one and vehicle two did not report being injured.

I first spoke with driver one identified as Ms. Eponine Watson. Ms. Watson said she was traveling east on Us Hwy 60 the #02 outside lane. Driver one said as she approached the intersection with the stop light, she was being told by passengers in her vehicle the lane ended and she needed to change lanes before the stop light.

Driver one said she quickly changed lanes and hit her brakes to stop because the traffic light had changed from green to yellow. Driver one said when she changed lanes she pulled in front of vehicle two also traveling east in the inside #01 lane and stopped. Driver one said vehicle two then rear-ended her vehicle.

I then spoke with driver two who said he was traveling east on the #01 inside lane and was approaching the traffic light that was green. Driver two said he saw vehicle one abruptly change lanes in front of him. Driver two said when driver one abruptly changed lanes she slammed on her brakes and stopped at the intersection, while the light was still green. Driver two said he attempted to stop however he did not have enough distance to get stopped due to driver one cutting him off. Driver two was also pulling a trailer loaded with a medium sized boat.

I located two witnesses on scene who are identified as Rick and Tina Douglas (417-592-7502 445 Ravewood Circle Neosho Mo 64850). Both Rick and Tina Douglas reported being stopped at the traffic light on the I-49 Exit Ramp in the same vehicle and they observed vehicle one traveling east on Us Hwy 60 in the #02 outside lane. They also observed vehicle two traveling east in the #01 inside lane. They reported the eastbound traffic light was green and they observed vehicle one switch lanes, pulling out in front of vehicle two and almost come to a stop in front of vehicle two at the green light. They further said vehicle two had no time to get stopped.

No measurements were taken due to vehicles being moved prior to my arrival.
