

On 06-15-2015 at approximately 1540 hours I responded to the intersection of south Neosho Boulevard and west Harmony Street, in reference to a traffic crash.

I arrived on scene and observed vehicle two a black Dodge Avenger (V2). V2 stopped on Neosho Boulevard facing south, the car appeared it was stopped at the stop light. I also saw vehicle one a dark green Chevrolet Avalanche (V1). V1 was approximately 15 feet behind V2; V1 was facing south too. I made contact with both drivers and I asked them to move the vehicles to the Orschleins Farm store parking lot, they moved the cars out off the roadway to open up all lanes of traffic.

I first spoke to the driver of vehicle two Laura Graves (D2). She stated she was traveling south on Neosho Boulevard approaching Harmony Street. D2 explained she saw the traffic light at the intersection was red so she was slowing down to come to a complete stop. She went on to say all of the sudden she was rear ended by a truck. D2 stated she did not need medical attention and her vehicle did not need to be towed from the scene.

I made contact with the driver of vehicle one Zachary McKee (D1). D1 stated he was traveling south on Neosho Boulevard. He said he was not paying attention and did not realize the vehicle in front of him was stopping. D1 explained when he finally saw the vehicle was stopping it was too late and he struck the back of her car. D1 said he did not medical treatment and his vehicle did not need to be towed from the scene.
