

On 06-15-2015 Officers were dispatched to the intersection of Hamilton Street and East McKinney Street for a report of a non-injury traffic crash.

Upon my arrival, I noted two vehicles in the intersection. I took photographs of the vehicles where they were when I arrived. I had the drivers of both vehicles move the vehicles out of the intersection to an adjacent parking area due to the traffic hazard imposed by the location of the crash.

I made contact with both drivers and both passengers to ensure all parties were unharmed and not in need of medical attention. All individuals stated they were not in need of treatment.

I made contact with the driver of a Ford Fusion bearing MO UK4H7U (Vehicle 2). I identified him as Jeremiah Wright by his Missouri Driver's License. Mr. Wright stated he was travelling south on Hamilton Street. He said as he approached the intersection at Hamilton Street and McKinney Street, he turned his left turn signal on and began making a left turn to go east on McKinney Street. He stated he noticed in the middle of turning, another vehicle entered the intersection. He said he tried to stop before the other vehicle struck him but was unable to do so.

I made contact with the passenger in Vehicle 2 identified as Sean Swain by his Tennessee Driver's License. He stated he was in front passenger of Vehicle 2. He said he noticed the vehicle and noted Mr. Wright attempt to stop.

I made contact with the driver of a Pontiac SL bearing MO HL8W9W (Vehicle 1). I identified the driver as Larry Little by his Missouri Driver's License. Mr. Little said he was driving north on Hamilton Street. He said he came to a stop at the stop sign and then proceeded to turn right to drive east on McKinney Street. He said he did not notice Vehicle 2 enter the intersection.

I spoke with the passenger of Vehicle 1 identified as Lacrinza Bankston by her California Driver's License. Ms. Bankston said she was sitting in the front passenger seat of Vehicle 1. She stated her shoulder was sore but refused medical treatment.

Vehicle 1 and Vehicle 2 were both driven from the scene by their owners.

I have nothing further to add at this time.
