

Once on scene I observed a white Chevrolet Cobolt, identified by the Missouri registration PH0P3A V1, facing east bound on Highway 60, just east of Kodiak Road. That vehicle was driven by Bailey Conklin identified by her Missouri driver's license.

I also observed a black Chevrolet pickup, identified by the Missouri registration 6PG842 V2, sitting on the east bound shoulder of Highway 60, approximately 100 feet east of the intersection.

I spoke with the driver of V1 Bailey Conklin. She told me there was a big truck in front of her and it turned south at the intersection and she said V2 was right there, and she rear ended it. V1 was inoperable and a non preference wrecker was contacted to remove V1 from the roadway.

I then spoke with the driver of V2 Richard Dodson identified by his Missouri driver's license. He explained he was sitting at the intersection waiting on a small dark car in front of him to go. He said V1 just ran into him striking him in the back bumper.

Ron's towing arrived on scene and towed V1. Both drivers declined medical treatment at the scene.
