



6. COLLISION DIAGRAM

On 08/16/2015 at approximately 13:17 hours officers responded to the 1600 block of South Neosho Boulevard to take a report of a crash.

I was driving along South Neosho Boulevard when I observed a red Suzuki 600 motorcycle bearing Missouri DB2NC lying on its side in the entrance to the parking lot of Save-A-Lot. The driver of the vehicle was standing next to it talking on his cellular phone. The vehicle was blocking the entrance and was leaking a liquid later to be identified as oil.

I made contact with the driver, Travis Boldts. He stated he was turning right to go into the parking lot when his motorcycle slid out from underneath him on the loose gravel/oil that was freshly placed by Missouri Department of Transportation (MODOT) earlier in the day. It should be noted MODOT was doing shoulder/ sidewalk work throughout the morning and afternoon.

He said he was ejected from the vehicle after it fell onto its side. He stated he could not see the loose gravel before he drove onto it. There was a MODOT sign warning drivers of the loose gravel and oil near the Neosho High School to the north of this location and one just to the south. He stated he did not drive by that sign. No workers were present and Mr. Boldts was not injured, other than an apparent scrape on his arm and refused medical treatment. His motorcycle was towed from the scene by a friend of his.

I have nothing further at this time.
