



On 09-08-2015 I responded to a non-injury traffic crash involving two vehicles just west of the intersection of West Coler Street and North Lincoln Street, on West Coler Street.

Upon my arrival I observed a 2006 white Dodge Ram truck identified by Missouri registration 6PV224 vehicle one (V1). V1 was stuck into a 2002 red Ford Mustang identified by Missouri registration CE7G4K vehicle two (V2). The impact to V2 was just in front the back right rear tire.

I spoke to Christopher Bach identified by his Missouri driver's license and the driver of V1. He advised he was following V2, both east bound. V2 drove to the left as if to get into the turn lane, but all the sudden started turning right and drove back right as to turn into the House of Donuts parking lot. Mr. Bach said V2 did not give him time to react he struck V2. Mr. Bach told me V2 did not have the turn signal on. I asked Mr. Bach if there were any witness. He told me there was a lady driving a blue car, but she left. He told me he did not know who she was.

I spoke to Michael Stribling identified by his Missouri driver's license and the driver of V2. He advised he was just turning into the House of Donuts parking lot and there were people standing in the parking lot and he did swerve to the right before turning to avoid them. Mr. Stribling told me he did have his turn signal on.

Mr. Bach and Mr. Stribling did not have any apparent injuries; nor did they request medical attention.

I spoke to customers at the House of Donuts and they advised they heard the crash but did not see what happened.

Both vehicles were operable and they were drove from the scene.

I filled out the Accident Information forms for both drivers. Photographs were taken and they are attached to this report.
