



On 09/09/2015 at approximately 10:46 hours officers responded to the 100 block of West Spring Street to take a report of a traffic crash.

When I arrived on scene I observed two vehicles were involved. Vehicle one was a white Hyundai sports utility vehicle bearing Missouri temporary tag 00XM0M. Vehicle two was a black in color Ford F250 bearing Missouri 74A3FG. Vehicle one was driven by Melissa Mincks and vehicle two was driven by Jerod Swartz.

I spoke to Mr. Swartz. He stated he was backing out of a parking spot on Spring Street to attempt to turn out onto the road when he was struck by vehicle one. He stated the other vehicle continued into the parking lot into a parking spot before stopping. He stated there was a scratch on his rear bumper from the incident. He stated he was not hurt and did not require medical attention.

After speaking with him I spoke to Ms. Mincks. She stated she was pulling into the parking lot off of Spring Street when she was backed into by vehicle two. She said she was not hurt and did not need medical attention. Her vehicle sustained minor damage to the driver's side area.

No vehicles were towed and were able to drive from the scene. No measurements of the area of impact were taken due to vehicle one relocating.
