




On 09/16/2015 at approximately 13:17 hours officers responded to the intersection of North College Street and Coler Street to take a report of a traffic crash.

When I arrived on scene to a parking lot across the street from Gastrip at the intersection of North College Street and Coler Street, I observed two vehicles were involved. Vehicle one was a black in color Chevrolet Impala bearing Missouri UH1X1B. Vehicle two was a silver in color Dodge Durango bearing Missouri PM8T8G. Vehicle one was driven by Martina Finley. Vehicle two was driven by Claude Collins. Both vehicles were off of the roadway in a vacant parking lot.

I spoke to Mr. Collins. He stated he was waiting at the stop light behind vehicle one to turn right onto Coler Street when vehicle one backed into his vehicle. He stated he was not hurt and did not need medical attention. His vehicle had minor damage to the front end and he advised he may not turn it into insurance.

After speaking with him I spoke to Ms. Finley. Ms. Finley stated she saw a truck driver motion for her to back up so he could turn the corner onto North College Street. She stated she did not realize a vehicle was behind her until she hit vehicle two. Her vehicle sustained minor damage to the rear of the vehicle. She stated she was not injured and did not need medical attention.

Neither vehicle was towed and was able to drive away from the scene.

I have nothing further to report at this time.
