

On 09/23/2015 at 2115 hours, I responded to West Coler Street West of North Valley Street to take a report of a traffic crash.

I arrived at West Coler Street approximately 250 feet west of North Valley Street. I saw a silver Honda Civic displaying Missouri registration (UJ3L7H) sitting west of the roadway in a creek bed. The vehicle appeared to be submerged in water up to the center console and interior seats. There was no one in the vehicle at the time of my arrival. I noticed a dent in the center of the front bumper along with a larger dent on the front driver side corner. Once the vehicle was lifted on the tow truck, I saw that 3 of the 4 plastic hubcaps were broken.

I noticed that the pavement on West Coler Street was wet. It appeared the vehicle made a large splash when it entered the waterway. Ron's Towing Company arrived on scene and took possession of the vehicle. On 10/14/2015 I received a call from Central Dispatch Center to respond to City Hall to speak with the driver of the vehicle at the time of the crash on 09/23/2015.

I arrived at City Hall and spoke with Velkey Gutierrez who translated for me. I spoke with Milton Alvarado-Lucas. Mr. Alvarado-Lucas stated he was the driver of the vehicle when it crashed into the waterway. Mr. Alvarado-Lucas stated he was travelling eastbound on West Coler Street when he looked down to plug his phone into the charger. He stated when he looked up, he saw that he was on the opposite side of the road. Mr. Alvarado-Lucas stated he attempted to hit the brakes but instead hit the acceleration pedal and crashed into a curb on the west side of the street then crashed into the creek bed.

I asked Mr. Alvarado-Lucas how much he had to drink that night. He stated he was at a friend's house eating dinner and had a beer. He stated he only had one. I asked him about the open container which would typically carry alcohol that was in the passenger compartment of the vehicle. He stated he was not done with his beer and brought it with him. Mr. Alvarado-Lucas stated he was not intoxicated.

Mr. Alvarado-Lucas informed me he did not have a driver's license or proof of financial responsibility. He stated he left the scene after the crash to find help. He said he went to a friend's house but no one was there. He stated he went back to the crash scene but his vehicle was gone.
