



MAIN NARRATIVE

On Tuesday, September 29, 2015 at approximately 1345 hours, I responded to the intersection of South Neosho Boulevard and West Daugherty in reference to a traffic crash. I arrived on scene and saw a red and a tan truck parked on the west side of La Questa Drive and a silver Jeep sitting in the outside lane of north bound South Neosho Boulevard. I made contact first with the driver of the silver Jeep, later identified as vehicle one, and identified her as Madison Dunfee.

Ms. Dunfee said she was traveling north on South Neosho Boulevard when she noticed a vehicle in the center turn lane facing south waiting to turn onto West Daugherty. She said she began slowing down because it looked like that vehicle was going to start turning, when her passenger, identified as Katelyn O'Bryan, yelled "Madison stop quick!" Ms. Dunfee said she looked forward and saw a red truck stopped in her lane of traffic behind a tan truck. She said she attempted to hit her brakes but was too close to the truck and struck it in the rear passenger side. Ms. Dunfee said she did not sustain any injuries and did not need to go to the hospital.

I spoke to the passenger of vehicle 1, Ms. O'Bryan, and she told me the same story as Ms. Dunfee. She said she was not paying that much attention to traffic ahead, and looked up and saw the red truck stopped in front of them. She said she yelled at Ms. Dunfee to stop, but it was too late and she struck the vehicle. Ms. O'Bryan was inspected by emergency medical services on scene but was not transported to the hospital.

I made contact with the driver of vehicle 2, the red Ford F-350, and identified him as Keith Estes. Mr. Estes said she was traveling north on South Neosho Boulevard when he noticed a tan truck in the same lane waiting to turn onto West Daugherty. Mr. Estes said he also saw a truck pulling a large trailer on West Daugherty facing west waiting to turn north onto Neosho Boulevard. Mr. Estes said it looked like his trailer was blocking the turn lane, preventing the tan truck from pulling onto the street. He said he slowed down and stopped behind the vehicle to wait for him to turn. He said at that time, he was struck from behind by vehicle 1. Mr. Estes said this caused his vehicle to go forward and strike the tan truck in the driver side rear bumper. Mr. Estes said he pulled his truck onto La Questa Drive so he would not be blocking traffic. Mr. Estes said he did not have any apparent injuries and did not need medical attention. There was minimal damage to the vehicle and Mr. Estes said he did not want to tow it. Mr. Estes said he did not see a vehicle in the center turn lane, but he was not looking for one.

I made contact with the driver of the tan truck, identified as vehicle 3, and identified him as Shawn Bowles. Mr. Bowles said he was facing north on South Neosho Boulevard waiting to turn east onto West Daugherty. He said there was a truck with a large trailer facing west on Daugherty waiting to turn north onto Neosho Boulevard and the trailer was blocking his lane of traffic, making it so he could not make the turn safely. He stated he heard a loud crash behind him and then felt something hit him from behind. He said he exited the vehicle and saw both vehicles behind him. He stated he moved his vehicle from the roadway onto La Questa Drive so he would not be blocking traffic. Mr. Bowles did not sustain any injuries and did not require medical attention. There was very minor damage to the vehicle and it did not need to be towed. Mr. Bowles said he did not see a vehicle in the center turn lane, but he was focused on the truck on Daugherty.

I did not take measurements or photographs of the vehicles due to all the vehicles being moved prior to my arrival. Ms. Dunfee said she attempted to move her vehicle onto La Questa Drive but the vehicle began to smoke so she stopped. The vehicle was towed by Poore's per Ms. Dunfee's request.
