





Driver 1(D1) Mary Fagan was in operation of vehicle 1 (V1) a 1994 silver Chrysler Concord bearing Missouri registration WE7X9D. D1 stated she was backing out of her driveway at 114 West Brook Street when she backed into a parked car on Brook Street.

Owner of vehicle 2 (V2) Erin Cooley was not in operation of V2 at the time of the crash. V2 was a 2014 tan Kia Forte bearing Missouri temporary registration 014EXQ. D2 stated she parked on the road in front of the alternative High School where she worked to get her purse. D2 stated when she was walking out she heard a crunch sound and saw V1 against her car.

The vehicles were moved prior to my arrival and the damage was minimal.
