



On 10/13/2015 at 0714 hours, I responded to the area of Business 49 and Highway 60 to take a report of a traffic crash.

I arrived at Business 49 north of Highway 60. I saw a green in color Nissan Quest displaying Missouri registration (SG7L4K) sitting on the west shoulder of the road. I saw a silver 2001 Hyundai Elantra displaying Missouri registration (KL1X0G) parked on the shoulder approximately 100 feet ahead of the Nissan.

I stepped out of my patrol car and spoke with the driver of the Nissan, Elizabeth Lemus. I asked Ms. Lemus if she was okay. She stated everyone was fine. I asked Ms. Lemus what happened. She stated she was driving northbound on Business 49 in the inside lane when someone in a silver Hyundai attempted to change lanes from the outside to inside lane. She said the vehicle went to the left and struck the passenger front corner of her vehicle. I looked at the Nissan and saw extensive damage to the passenger front corner. The passenger side of the front bumper had been bent forward revealing a broken plastic fender well. I also noticed the passenger headlight lens was broken.

I walked up to the Hyundai and spoke with the driver, Laurel Sexton. I asked if she was injured. She stated she was not. I asked Ms. Sexton what happened. She said she came from the east on Highway 60 and went north on Business 49. She stated she stayed in the outside lane for a moment then signaled to move into the inside lane. She said she looked and did not see any vehicles. She said she veered into the inside lane and struck the Nissan with the driver rear corner of her vehicle. I looked at the vehicle and saw a broken tail light lens on the driver side. I also saw a scuff mark on the driver rear portion of the bumper.

I have attached photographs of the damage sustained to both vehicles to this report.
