

On 10/23/2015 at 0902 hours, I responded to 215 West Hill Street to take a report of a traffic crash that occurred at the intersection of East South Street and Pineville Road.

I arrived at 215 West Hill Street and spoke with Chelsy Laster. Ms. Laster stated she was involved in a traffic crash with a black truck at approximately 0850 hours on 10/23/2015.

I asked Ms. Laster if she was injured. She stated she was not. I asked her what happened. She stated she was travelling on the round-a-bout, and was about to turn onto Pineville Road to go to Crowder College. She said she saw a black truck travelling east on East South Street. She said she figured the truck would stop and yield to her but it did not. Ms. Laster said the truck hit her passenger side. I looked at Ms. Laster's vehicle which was a white 2007 Toyota Camry displaying Missouri registration (HD8M4D). I noticed the passenger side front door was severely damaged and would not close fully. I also noticed damage on the front of the vehicle. I asked Ms. Laster about it and she stated the damage on the front of her car was there prior to the crash. Ms. Laster did not know the other drivers name but had his insurance information.

Ms. Laster gave me the license plate number for the other vehicle. I ran the license plate through MULES and it showed the owner as RC Burgess and Daisy McCoy. I recognized the name "Daisy McCoy" from a medical call that I responded to earlier. I travelled to Freeman Neosho Hospital and found Ralph Burgess, the driver of the other vehicle involved in the crash. I spoke with Mr. Burgess who stated he was in a crash earlier that morning. I asked Mr. Burgess what happened. He stated he was coming from West South Street and attempting to get on the round-a-bout. He stated he struck a white passenger car which he said he believed was speeding.

I travelled to 325 Park Street where Mr. Burgess said he left the vehicle. I arrived and saw a black 2002 Ford F-150 displaying disabled Missouri registration (0CP84). I looked at the vehicle and saw that the driver front corner of the vehicle had damage. The driver front portion of the bumper had been pushed in and was almost touching the driver front tire.

I took photographs of the damage sustained to both vehicles. I have attached copies of the photographs to this report.
