

On 10-26-2015 around 08:08 hours, I was dispatched to the intersection of Highway 60 and Highway 59 in reference to a non-injury traffic crash.

Upon my arrival, I observed a brown pickup truck, vehicle two (V2) and a green passenger vehicle, vehicle one (V1) parked on the shoulder of Highway 59. I observed a male, later identified as Kevin Cron to be the driver of V2; standing next to a female, later identified as Jessica Hill the driver of V1. I asked both drivers if they were injured and they told me they were not.

I spoke with Ms. Hill; she stated she was behind V2, turning south onto Highway 59. She said V2 started to enter the intersection and she went to move forward. She said she turned her head to watch for the traffic and V2 had stopped while she was not looking. She said she struck the rear end of V2 before she realized that V2 had stopped.

I spoke with Mr. Cron; he stated he started to enter the intersection, but noticed a vehicle traveling at a fast rate of speed. He said he stopped to wait for the vehicle to pass then he was struck in the rear end by V1.
