


On 10-29-15 at approximately 1902 hours, I was dispatched to the area of Johnson Drive and Neosho Boulevard for a traffic crash that occurred at approximately 1700 hours.

Upon arrival, I met with Blane Johnson. He was standing near a 1995 Ford F-250 bearing Missouri registration 6YR000 on the east side of Neosho Boulevard. He said he was involved in a traffic crash at approximately 1700 hours. He said he was traveling northbound on Neosho Boulevard and a vehicle came from Johnson Drive and struck the driver's side of his vehicle.

Mr. Johnson said someone passing by told him they called police but we didn't arrive for approximately 2 hours. It was later determined that no one called the crash in and the Neosho Fire Department drove up on the accident 2 hours later.

I spoke with Jeri McElroy in the parking lot of Casey's. She said she was turning off of Johnson Drive onto Neosho Boulevard. She said another vehicle was coming southbound and she swerved to get out of the way. She said she struck the other vehicle that was northbound on Neosho Boulevard. She told me she did not really know how it happened or what other vehicles were around.

Ms. McElroy had two passengers, Keaton Danner in the front right seat and Tracy Rea in the second row right seat. Mr. Johnson had one passenger, Ronald Halverson in the front right seat. None of the parties involved were injured and both vehicles were drivable.

I have nothing further at this time.
