



On 11/2/15 at around 1641 hours officers were dispatched to the area on North College Street and West Coler Street in reference to a traffic crash.

I arrived on scene and made contact with Driver 1 (D1) Zlatko Gunic who was in operation of Vehicle 1 (V1) a white 2005 Volvo semi truck with a box trailer bearing Missouri registration 45AS3H. D1 stated he was eastbound on West Coler Street and turned left onto North College Street. D1 said there was a vehicle in the left turn lane he could not maneuver around. D1 said the vehicle backed up and he pulled around it. D1 added the vehicle then pulled forward before his trailer was clear. D1 explained he drove his truck off the road to the right to swing his trailer around the vehicle. D1 hit a power pole with the corner of the trailer V1 reentered the roadway.

The pole had missing wood from the impact and the transformer was leaking fluid from being shaken and punctured by the mounting bracket.

I spoke to Shane Slavens of Empire Electric. He informed me the pole would not be replaced, only the transformer. He estimated the cost of a transformer and labor to be around \$1000.

Nothing further.
