


On November 18th, 2015 at about 1759, I responded to the intersection of Highway 60 and Lusk Drive in reference to a traffic crash.

Upon arrival I spoke with David Darch, driver 3. Mr. Darch stated he was stopped on Highway 60 at the intersection with Lusk Drive. He stated there was one other car in front of him. Mr. Darch stated the light turned green and the vehicle in front of him did not immediately move. Mr. Darch stated at that time the vehicle behind him, vehicle 2 struck the back of his vehicle. Mr. Darch stated his neck was sore as a result of the crash, but he did not need an ambulance.

I observed the rear of vehicle 3 was damaged as a result of the crash. The vehicle was operable and Mr. Darch drove it from the scene.

I spoke with Stanley Doggett, driver 1. Mr. Doggett stated he was traveling east on Highway 60 approaching the intersection of Lusk Drive. He stated he observed the light was green. He stated he then looked up and the vehicles were not moving. He stated he did not have time to stop and drove into the back of vehicle 2.

Mr. Doggett stated he was not injured as a result of the accident. I observed the front end of vehicle 1 was damaged as a result of the accident. The vehicle was operable and Mr. Doggett drove it from the scene.

I observed vehicle two was damaged as a result of the accident. The vehicle was inoperable and was towed by Affordable towing by the request of the owner.

Jeremy Whatley, driver 2 was taken to the hospital by ambulance due to injuries he sustained during the crash. I later spoke with Mr. Whatley. He stated he was stopped on Highway 60 at the intersection with Lusk Drive. He stated they were stopped in traffic when suddenly his vehicle was struck in the back.

I have nothing further to report.
