




When I arrived on scene I observed two vehicles were involved. Vehicle one was a 1986 Chevrolet truck bearing Missouri 4WU036. Vehicle two was a 2000 Ford Mustang bearing Missouri MJ9K8Y. Vehicle one was driven by Allen Mathews and vehicle two was driven by Kody Martinez.

He stated he was not injured and did not need medical attention. His vehicle sustained minor damage to the front end and was able to drive away from the scene.

He stated the first vehicle honked its horn at him, which caused him to turn and look. He stated he was not injured and did not need medical attention. His vehicle sustained damage to the passenger rear but was able to drive his vehicle from the scene.
