





Upon my arrival to the scene, I observed a male later identified as Scott Gallup standing next to a silver Toyota Camry, vehicle 2. Mr. Gallup stated he was inside Community Bank and Trust for a few minutes. He said he was about to leave when he was stopped by someone and they told him that his vehicle was hit by a red pickup truck, vehicle 1, which was currently in the Community Bank and Trust parking lot. He said although he did not see the crash happen, he was able to find V1 in the parking lot which had fresh damage to the running boards on the passenger side. Mr. Gallup said he was currently renting V2 from Enterprise and they would need a report of the damage.

Mr. Gallup informed me that the witness did not stick around and he not provide his name or contact information.

While speaking with Mr. Gallup, the driver of V1 approached me and I identified her as Eltiana Santos. Ms. Santos told me she was dropping off her aunt at the eye doctor for her appointment. She said after she dropped her off, she went to park her pickup truck and struck V2 in the front driver side panel which left an approximate 8 inch long scrape. Ms. Santos said she ended up parking in the parking lot and had to go in and check on her aunt, before she started looking for the owner of V2.

V1 only had minor damage to the running boards.
