

On 03-29-2016 I responded to West Coler Street and North College Street to a non injury traffic crash. Upon my arrival I observed a grey 2008 Mitsubishi Eclipse identified by Oklahoma registration 646LLU and the driver identified by her Missouri driver's license Z202112002, Koda Hatfield-Stephens. I also observed a blue 1986 Ford Ranger identified by Missouri registration 8HV966 and the driver identified by his Missouri driver's license T980694521, Dalton Carpenter. The Ford Ranger also had a passenger identified by his Missouri driver's license, Alan Bryant.

The vehicles were both resting in the west bound lane of traffic, approximately 30 feet west of the intersection. I took a photograph of the vehicles and advised both parties to meet in a parking lot a block west of the location so I could get their information for the report. Ms. Hatfield-Stephens vehicle (V2) was operable and she was able to move it. Mr. Carpenter's vehicle (V1) was not operable and it was pushed into the parking lot of Gas Trip. It had a battery issue due to the impact and was shortly fixed and drove away from the scene.

Ms. Hatfield-Stephens told me she was stopped with her left blinker on waiting on traffic so she could turn into the Gas Trip parking lot and she was struck in the rear bumper area of her car by the Ford Ranger.

Mr. Carpenter told me he was making the right turn onto West Coler Street and he said he was looking over his left shoulder to make sure there were not any vehicles coming. He said he looked forward and he saw V2 stopped to turn left. He said he hit his brakes but he was to late striking V2 in the rear bumper.

There were no apparent injuries and both vehicles were drove from the scene.
