


On April 12, 2016, I responded to the intersection of business 49 and highway 60 in reference to a report of a two vehicle non injury traffic crash.

Upon my arrival I spoke with both drivers and they advised me that they were not injured and did not need any medical treatment. The driver of vehicle 1, Francisco Villa, stated that he was sitting at the stop light facing north. He stated that his light turned green and he proceeded to accelerate through the intersection. Mr. Villa stated that he didn't even see the other vehicle coming before he hit the side of the vehicle. After the crash both driver's moved their cars to the shoulder of Highway 60 to not block the flow of traffic.

I spoke with the driver of vehicle 2, Letha Roller, and she stated that she was heading south on Business 49. Ms. Roller stated that she was going to make a left hand turn onto Highway 60. Ms. Roller said that she saw the traffic light was yellow before she turned. She stated that the light might have turned red but she did not see it before she turned. As Ms. Roller made the left turn a vehicle that was heading north hit her in the passenger side of her vehicle. After the crash she moved her vehicle to the edge of the road.
