



On 5/11/16 at around 2036 hours officers responded to the area of Howard Bush Drive and Burr Crossing in reference to a single car traffic crash.

I arrived on scene approximately 800 feet south of Burr Crossing on Howard Bush Drive. I observed a car off the roadway on east side in the tree line. The driver was out of the vehicle speaking to the fire crew.

I made contact with Driver 1(D1) Andrew Knapp identified by Missouri driver's license. D1 was in operation of a Vehicle 1 (V1) a 2001 Silver Nissan Sentra bearing Missouri registration CE7G6M. D1 said he was driving south on Howard Bush Drive at 40mph when a deer ran into the road. D1 said he swerved to miss the deer and slide off the east side of the road and struck a tree.

D1 said he was not injured but was tired and didn't feel good. D1 said his father was going to take him to the hospital in case he had a concussion. D1 denied transport from a ambulance.

Photos were taken of the vehicle and added to this report. The vehicle was removed by Neosho Towing.

From my investigation I found tire scuff marks on the roadway that showed the vehicle slid 90 degrees counterclockwise before leaving the roadway. Tire marks in the grass showed the vehicle rotated approximately another 45 degrees before striking a tree on the passenger side.
