

On 06-06-2016 around 1248 hours, I was dispatched to the intersection of Highway 60 and Highway 59 for a non injury traffic crash.

Prior to my arrival to the scene Central Dispatch Center (CDC) stated the reporting party, (later identified by her Missouri driver license as Kirstyn Ramsey) advised a Chevrolet Equinox, vehicle 1 (V1) the backed up into her Kia Soul, vehicle 2, (V2). CDC stated Ms. Ramsey told them the male driver, later identified by word of mouth and social security number as, Dakota Wead and female passenger had switched seats shortly after the crash.

Upon my arrival I spoke with all party's involved and asked if anyone needed medical attention. All party's declined medical attention.

I spoke with the driver of V2, Ms. Ramsey; she stated she was sitting at the red light when V1 started to go into the intersection. She said he stopped and started backing up towards them. She said she started honking her horn to warn V1 but it struck her in the front end. She said she then saw the male driver switch seats with the female passenger.

I approached V1, with the female in the driver seat, identified by her Oklahoma driver license as Sunnie Doyle and Mr. Wead in the passenger seat. I spoke with Mr. Wead; he stated he did switch seats because he did not want to get into more trouble than he already is. He stated V2 was honking the horn and he thought the light had turned green. He said as he started to enter the intersection he noticed the light was still red so he stopped and started to back up. He said he then backed up into the front end of V2.
