


On 06/14/2016 I responded to the area of South Neosho Boulevard and West Daugherty Road to take a report of a traffic crash.

I responded to South Neosho Boulevard south of West Daugherty Road and saw a vehicle on the shoulder of the road with the flashers on. I later learned the vehicle had struck a deer.

I spoke with the driver of the vehicle, Timothy Richhart; and asked if he was injured. He stated he was not. He stated he was travelling north on South Neosho Boulevard in the outside lane when a deer ran in front of his car. He said he struck the deer with the front of his vehicle. I looked at Mr. Richhart's vehicle, a black 2009 Ford Fusion displaying Missouri registration (SK5J5H). I noticed damage to the front middle portion of his vehicle. The hood was damaged near the grill and the driver side portion of the windshield was cracked due to the airbag deployment. Mr. Richhart stated he wanted Poore's Salvage to tow the vehicle. I had Central Dispatch Center contact the tow company.

I looked at the deer, it appeared to be deceased. I asked dispatch to attempt to contact someone that could pick the deer up. They later informed me no one was available and that Missouri Department of Transportation would take care of it. Poore's Towing arrived on scene and towed the vehicle. I took measurements from the point of impact to West Daugherty Road which measured exactly 1,281 feet.
