



On 06/22/2016 at approximately 1236 hours, I responded to the intersection of Waldo Hatler Memorial Drive and Neosho Boulevard to take a report of a vehicle crash.

When I arrived on scene I noticed a gray Ford Explorer Sport (Missouri 4WU059) with front end damage in the turning lane facing southbound on Neosho Boulevard.

I noticed a black GMC Jimmy (Missouri FD8Z0J) in the right lane with driver side damage laying on its passenger side blocking both lanes of traffic facing northbound on Neosho Boulevard.

I made contact with the Driver 1 (William Morgan) he stated that he was traveling southbound on Neosho Boulevard when vehicle (2) pulled out in front him and caused him to crash.

Driver (2) also stated that he did not noticed driver (1) when he pulled out onto the road way.

Ambulance did arrive on scene and checked everyone that was involved, William Landreth who was passenger of vehicle (2) was transported to Mercy Hospital in Joplin Mo. Poore's Towing also arrived and towed both of the vehicles.
