

On July 2, 2016 at approximately 04:14 an officer responded near the intersection of Highway 60 and Adams Street to take a vehicle crash report.

Upon my arrival near the intersection of Highway 60 and Adams Street I made contact with a Mr. Larry Elsey, he was identified by his Missouri Operator License. He said he was on his way home in Aurora from the Casino when it started raining. Mr. Elsey said it was raining so hard he could hardly see the road. The next thing he knew he hit the concrete curb for the signal light, causing damage to his car.

I asked if he was injured and needed Emergency Medical Services (EMS) to respond. He said neither he nor his passenger was injured. He requested a tow company to respond to tow his vehicle back to his home in Aurora Missouri. I asked him if he had a preference in a tow company, he said he was not from here and did not have a preference. I notified Central Dispatch to contact a non preference tow company to respond, and to advise them the owners of the vehicle were in need of a ride back to their residence in Aurora Missouri. I photographed the damage to the vehicle, the photographs will be attached to this report.
