



On 07-08-16 at approximately 1420 hours, I was dispatched to the area of Lusk Drive and Clemon Drive for a report of a non-injury traffic crash.

He said he had two passengers in his vehicle. Jacob Robbins was in the front passenger side seat, and Mark McDonald was in the rear passenger side seat. Mr. Seeley said he was stopped getting ready to make a left hand turn into Wal-Mart when his vehicle was struck from behind. He said he was able to drive his vehicle and they were all not injured.

I collected all of the information needed for the report and released all involved parties.
