


MAIN NARRATIVE

On 07-14-2016 I responded to 800 South Neosho Boulevard (TDS Portable Buildings) in reference to a non injury traffic crash. Upon my arrival I found a tan Honda Civic identified by Missouri registration UD7D6Y crashed into a storage shed. The driver/owner of the vehicle was still sitting in the vehicle, Mary Bielby identified by her Missouri driver's license. Ambulance personnel were attending to her.

Also on scene I spoke with two witnesses, Kaylin Schatzer identified by her Missouri driver's license and Sean Seaton, identified by his Oklahoma driver's license. They told me they watched Mrs. Bielby drive her vehicle across South Neosho Boulevard heading west from 719 South Neosho Boulevard (Mitchell's Drug Store), then into the parking lot of 714 South Neosho Boulevard (Great Southern Savings Bank). They explained she drove around the back side of bank and then drove south through a ditch and drove across Bond Street. Mrs. Bielby then entered the property at 800 South Neosho Boulevard and drove her vehicle into the storage shed, coming to a stop.

Mrs. Bielby was asked what happened and she advised her foot got stuck on the accelerator. I asked Mrs. Bielby if she got anything at Mitchell's Drug Store and she could not remember. I asked if there was anyone that I could call to have them come and pick her up, because her vehicle had to be towed due to front end and radiator damage. She replied by saying, "I don't know, my mind has drew a blank." I asked who she wanted to come tow her car. Once again, she told me her mind has drawn a blank. I had Ron's Towing, a non preference wrecker respond to tow the vehicle.

Mrs. Bielby refused medical treatment. She did finally ask for me to call the Rocketdyne Church, she said someone from there will come get me. I had the Central Dispatch Center call the number they had on file for the church and shortly I received a call from church member, Jimmy Sexton. He told me he would come and get her. Once Mr. Sexton arrived he told me someone from the church will sit with Mrs. Bielby and try and get her to go to the hospital to get checked out. Mr. Sexton told me he has known Mrs. Bielby for 20 years and he explained she has episodes of forgetfulness from time to time. He said she may be progressing.

Photographs were taken of the scene and they are added to the Photo Albums section of this report.

Ron's Towing did respond and tow the vehicle. The storage shed is owned by TDS Portable Buildings and I spoke to the Manager of the property Daniel Hicks on scene, and I gave him Mrs. Bielby's insurance information.

I will be submitting a retest form to the State of Missouri for Mrs. Bielby.
