


On 07-27-2016 I responded to a two vehicle traffic crash at the intersection of Highway 86 and south bound on and off ramps of I49. Once on scene I observed a 2004 dark blue Chevrolet Tahoe sitting under the overpass of I49 with the front driver's wheel off of the Tahoe. That vehicle was identified by Missouri registration UL6R3D, vehicle two (V2). I also observed a 2009 light blue Ford Focus identified by Missouri registration FM7M0S, vehicle one (V1).

I spoke with the driver of V2, Bobby Holland identified by his Missouri driver's license. He told me he was traveling east bound on 86 highway and V1 just came over in his lane to turn onto the south bound on ramp of I49, striking his vehicle.

I then spoke to the driver of V1, Crystian Rose identified by his Missouri driver's license. He told me he was turning to get on the south bound on ramp and he said he did not see V2 coming.

I then spoke witness, Courtney Padilla identified by her Missouri driver's license. She told me V1 just pulled right out and into V2. She said just like V2 was not even there.

Mr. Holland called Poore's Truck Salvage and Towing to tow the Tahoe. Mr. Rose's mother Shannon Rose and owner of V1 came to the scene and she called Ron's Towing and had them come and tow V1.

Both drivers's had no apparent injuries and they both left with family members. I also filled out the accident information forms for the drivers.
