




6 COLLISION DIAGRAM



On 09/04/2016 I responded to the intersection of Kentland Drive and Stratford Place to take a report of traffic crash involving a fixed object.

I received a call from Central Dispatch Center stating a male subject was involved in a traffic crash and fled the scene on foot. While enroute to the scene, Ofc. Tyree made contact with the male subject on Freeman Road.

I responded to the traffic crash at the intersection of Kentland Drive and Stratford Place. I observed a green Nissan Frontier displaying Missouri registration (2SZ498) crashed into a light pole. The vehicle was facing north and appeared to be coming from Kentland Drive. I searched the vehicle and did not find anyone inside. I did locate an open bottle of Bud Light on the passenger side between the passenger seat and door. Both driver and passenger side airbags were deployed. There was extensive damage to the front of the vehicle.

I spoke with witness, Joseph Davis. Mr. Davis stated he heard a loud crash and came outside and saw a Hispanic male come from the vehicle that was crashed into the pole. He said the male subject was wearing a white shirt with coloring on the chest portion. He said there was also a stain on the shirt. Sgt. Whitehead confirmed it was the same subject, Ofc. Tyree made contact with on Freeman Road.

Ron's Towing arrived on scene and took possession of the vehicle. I have attached photographs of the damage sustained to the vehicle and the light pole (# EDE 615669). Nothing further at this time.
