

On 09-12-16 at approximately 1540 hours, I was dispatched to the area of Howard Bush Drive and Lyon Drive for a report of an injury traffic crash involving one vehicle and a motorcycle.

Upon arrival, I met with Trenton Thomas, identified by his Missouri driver's license. He had obvious injuries to his arms and legs from skidding across the pavement. He said he was operating the motorcycle that was lying on the ground on the side of Lyon Drive. The motorcycle (V-2) was a 2015 Harley Davidson Dyna bearing Missouri registration DE8XR.

Mr. Thomas said he left work, La-Z-Boy, and was traveling west bound on Lyon Drive on his motorcycle. He said he was traveling at approximately 40 miles per hour in 2nd or 3rd gear when he approached Howard Bush Drive. He said a vehicle came across Lyon Drive headed north on Howard Bush in front of him and he attempted to stop. He said he locked up the brakes; the motorcycle fell onto the right side, and slid through the intersection. Mr. Thomas said he thought he struck the other vehicle but was not sure. Mr. Thomas was transported to Freeman Neosho Emergency Room by his wife in their personal vehicle.

I spoke with Ray Cunningham, identified by his Missouri driver's license. He said he was driving a maroon 2013 Ford Fusion (V-1) bearing Missouri registration CG4H1X traveling north bound on Howard Bush Drive. He said he came to a stop at the stop sign at Lyon Drive and waited for traffic to clear on Lyon Drive before heading across the intersection. He said he never saw a motorcycle until after the crash had already occurred. He told me he did not know he was involved in a traffic crash because he did not feel an impact or see the other vehicle.

I looked at Mr. Cunningham's vehicle and did not see any damage. Mr. Thomas thought he and/or the motorcycle struck Mr. Cunningham's vehicle but I could not observe and physical evidence of that contact. The motorcycle had scratches on the right side of it showing that it slid across the pavement but no other damage showing that it impacted another object.

I have nothing further at this time.
